HEDNESFORD TOWN COUNCIL

MINUTES OF A MEETING OF THE COUNCIL HELD AT 7:30 PM ON TUESDAY 12 NOVEMBER 2019 AT PYE GREEN COMMUNITY CENTRE

PRESENT: Cllrs P Woodhead (Chairman and Communications and Engagement Speaker), R Kingston (Vice-Chairman and Community Projects and Events Speaker), K Downs (Youth and Community Cohesion Speaker), M Dunnett (Environment Speaker), A Fittes (Planning and Economic Development Speaker), S Jagger (Wellbeing, Isolation and Loneliness Speaker) and A Roden (Highways Speaker)

IN ATTENDANCE: P Harrison (Town Council Manager/Clerk), District Cllr A Pearson and 3 members of the public

APOLOGIES: Town Cllrs D Cartwright and G Jones, County Cllrs P Hewitt and B Jones and PCSO R Evans Staffordshire Police

Earlier in the evening members had received a presentation from Ms H Pigott on the "Chase Up!" Inspiring Healthy Lifestyles (IHL) project which would be concentrating on a particular area of the Hednesford North Ward. It was agreed that there were several opportunities for the Council to collaborate with this initiative which would be ongoing for the next 5 years. The Council and IHL would be proactive in pursuing the shared opportunities as they arose and would work closely to promote the project and with the employees when they were appointed

PUBLIC PARTICIPATION

Prior to the formal commencement of the meeting several matters were raised. It was reported that there had been an apparent escalation of incidents involving drugs and that drinking of alcohol in public places was also becoming an issue. The situation at the moment was that until there had been further recruitment and training there were limited police resources available. However, it was considered that liaison with the local PCSO was essential and that it might be appropriate to consider the implementation of something like a Public Places Protection Order. The Town Council would ask the District Council Safety Partnership Team what measures had been taken to address the problem in Cannock Town Centre and to ensure that this had not been displaced to Hednesford Town Centre

As they were unable to attend the meeting the police had submitted a written update report. This showed some reductions in crime, but it was stated that problems experienced in the public reporting crime may have distorted the figures. Mention was also made of the need to ensure there was no increase in violent incidents arising from the activities of organised gangs

Reference was made to the Remembrance Sunday commemorations and that this event had attracted more people than ever before. The Royal British Legion had been thanked for organising the event. However, due to the large numbers attending there was a need for additional marshalling and for

improved coordination of future ceremonies. It was anticipated that all the town organisations would support each other regarding this. Ideas were discussed around the use of technology to help share the service across everyone who attended

It was reported that work had been carried out to remove graffiti from the pedestrian section of the Station Road bridge and consideration was being given to placing artwork on the bridge panels

A request was made for a volunteer to take on board the responsibility for organising "Places of Welcome" at the library. This would be raised with the Friends of Hednesford

Industrial action would be affecting the Chaseline on every Saturday during November and December with no trains or replacement buses serving Hednesford. It was also reported that some vandalism had occurred at stations on the line but not at Hednesford

1. MINUTES

The minutes of the meeting held on 10 September 2019 were approved as a correct record

2. TOWN COUNCILLOR RESIGNATION

It was reported that Cllr M Deakin had submitted his resignation as a Town Councillor. The vacancy had been advertised but there had been no demand from electors for a poll to be held

RESOLVED:

That persons interested in filling the vacancy be invited to put their names forward for consideration with a view to the Council filling the vacancy by cooption at the next meeting on 17 December 2019 (Members were asked to promote the vacancy to attract the widest interest)

3. CHAIRMAN'S ANNOUNCEMENTS

The Chairman reported the sad news of the death of long serving District Cllr Gordon Ball

The Chairman had attended several Remembrance events including the commemoration at the War Memorial where he had laid a poppy wreath on behalf of the Council, the silence in Anglesey Square at 11:00 am on 11 November and an event held at Kingsmead School

The Silver Sunday event had been a great success and the Chairman thanked everyone who had taken part in the organisation

The Chairman congratulated all those involved in Hednesford Park receiving a gold Britain in Bloom Award for the third year running at the Britain in Bloom regional awards

Plans for the Christmas event were well underway and the Chairman expressed the hope that the event on 6 December would be as successful as in previous years and asked all members to help on the day

The Chairman had attended the NALC Conference where he had sat on a panel debating the Climate Emergency and was pleased to report that the conference had agreed a motion regarding this. Whilst there he had also had the opportunity of meeting HRH the Princess Royal who had given a speech supporting the work of local councils and their members

- i) National Community Energy Campaign That the Council
 - (i) acknowledges the efforts that this Council will make to reduce greenhouse gas emissions and promote renewable energy;
 - (ii) recognises that councils can play a central role in creating sustainable communities, particularly through the provision of locally generated renewable electricity;
 - (iii) further recognises
 - that very large financial setup and running costs involved in selling locally generated renewable electricity to local customers result in it being impossible for local renewable electricity generators to do so.
 - that making these financial costs proportionate to the scale of a renewable electricity supplier's operation would create significant opportunities for councils to be providers of locally generated renewable electricity directly to local people, businesses and organisations, and
 - that revenues received by councils that become local renewable electricity providers could be used to help fund local greenhouse gas emissions reduction measures and to help improve local services and facilities;
 - (iv) accordingly resolves to support the Local Electricity Bill, currently supported by a cross-party group of 115 MPs, and which, if made law, would make the setup and running costs of selling renewable electricity to local customers proportionate by establishing a Right to Local Supply; and

(v) further resolves to

- inform the local media of this decision,
- write to local MPs, asking them to support the Bill, and
- write to the organisers of the campaign for the Bill,
 Power for People expressing its support

(Cllr P Woodhead declared an interest in this matter)
