Poll cards tell people when to vote and at which polling station, you can vote without a polling card and it is not the ballot paper.

It must be noted that the election and poll cards are only required if 3 or more people stand for the 2 vacancies; if 2 stand then there will not be an election.

It is proposed that, in the event of more than two candidates standing for election, the Council does opt for poll cards to be issued to inform the electorate and remain open and transparent of the process.

MINUTES OF THE MEETING OF HEDNESFORD TOWN COUNCIL

Tuesday 7<sup>th</sup> December 2021 at 19:00 Meeting held at Pye Green Community Centre, Bradbury Lane, Hednesford. Members of the public were invited to attend in person and online via Zoom. The meeting was also live streamed to the Council Facebook page.

## Members of Public:

14 members of the public attended. Local Police were also in attendance.

## **Public Participation:**

Cllr Kathryn Downs read out a statement to the public addressing the online abuse that Councillors had been subjected to in recent days, summarising the good work that had been achieved by the Council over the past 18 months and reinforcing the message that we should all be kind and respectful of one another. The statement addressed the public anger following the leak of confidential information surrounding the lease of Pye Green Community Centre.

Mayor Emma Hunneyball explained to the members of the public present in the room and online that a confidential Council paper had been leaked to the public prior to Council having the opportunity to discuss and resolve. This leak had led to the interest surrounding the Council meeting and Mayor Hunneyball confirmed that the Council would answer as many questions as they could during the public section of the meeting.

This was followed by a lively question and answer session with questions from the public regarding the future of Pye Green Community Centre and the Council Paper to be discussed in private business tonight.

Councillors confirmed that they wished to dispel rumours circulating online and said they could confirm that all options contained within the confidential Council Paper to be discussed this evening retained Pye Green Community Centre as a local community centre and they also confirmed that no organisation was being granted sole hire of the centre.

Any questions relating directly to the detailed contents of the confidential Council Paper could not be answered as the Paper had not yet been considered, discussed or debated by Council and to do so would breach Standing Orders.

## 1. Apologies – Cllr Darrell Mawle due to holiday.

2. Declarations of Interest – Cllr Debbie Cartwright advised that she had submitted a formal request to the Council which will be read out by Michelle Baker on her behalf in relation to agenda item 6.i. Cllr Cartwright also advised that in respect to agenda item 10, Chase Lighthouse (an organisation she had co-founded) were users of Pye Green Community Centre (PGCC) and that she wished to raise a declaration of interest. Mayor Emma Hunneyball advised that she also wished to raise a declaration of interest in respect of agenda item 10 which she would discuss further in private business.

# 3. Minutes. To review and approve the minutes of the Full Council Meeting held on 2nd November 2021.

Cllr Debbie Cartwright and Cllr Laura Harrison said they would like it publicly noted that they would have preferred that the PGCC hirers were consulted reference the item in private business.

The Task Force members requested it to be noted that this would not have been possible whilst complying with the Council's duty of care as an employer and it would have been at high risk of having a prejudicial impact on the commercial operations of the community centre.

Cllr Arthur Roden requested that it be noted that he had been excluded from the vote on the item in private business as he was asked to leave the meeting, due to his conduct in the meeting.

Resolved by unanimous vote (9 votes), minutes approved.

## 4. Mayor's Announcements

**I. Christmas lights switch on event.** – Mayor Emma Hunneyball congratulated all involved in organising the event and said it had been hugely successful with a combination of market traders, community stalls, school choirs and attractions such as stilt walkers and illuminated fairies.

**II. Cancelled November Farmers and Craft Market due to weather**. – It was unfortunate that November's market had to cancel due to heavy snow.

**III. Next Market Sat 11th December with snow globe.** – The life-size snow globe will feature at our next market which is free for visitors to come and have their photo taken inside, the Nutcracker trail is also in town.

**IV. Opening of The Village pub.** - Mayor Emma Hunneyball said she was honoured to be asked to open this new venue in town, which intends to host a range of events.

V. Fireworks panto. – The local charity Fireworks that supports children's mental health and wellbeing have organised a free pantomime for the local community. Due to the snow on Saturday it was cancelled and moved to the Sunday with Mayor Hunneyball in attendance. Extra Item – Mayor Emma Hunneyball attended a carol concert hosted by Hednesford Town Football Club which was a wonderful event with the Salvation Army also participating.

## 5. Update from the Responsible Finance Officer (RFO)

**I. Draft budget 2022 / 23 and precept deadline.** – A draft budget has been circulated to all Councillors in advance of the meeting and necessitated feedback from Councillors. Sandie Morris said the Council is awaiting the estimated precept figure from Cannock Chase District Council and once received this will be added to the budget.

**I. Formal request received from Chase Lighthouse** – Michelle Baker read out the formal request from Cllr Debbie Cartwright on behalf of Chase Lighthouse, requesting permission to use Pye Green Community Centres reception area for the community food table every

Sunday during the winter months to prevent service users having to wait outside in the cold. Cllr Debbie Cartwright agreed that if granted, she would not leave the area unattended until the key holder (staff) returned to lock up when the dance class had finished and that she would work around current hirers so as not to create additional work for the keyholder.

Resolved permission given by 8 votes, Cllr Paul Woodhead abstained.

**II. The final Farmers and Craft market of the year will be held this Saturday 11<sup>th</sup> December.

## 9. Private and Confidential Business

## Abbreviated minutes detailing the salient points only due to the item being held in private business and confidential matters discussed.

Mayor Emma Hunneyball raised a declaration of interest as her child is a member of the Scouts. Cllr Debbie Cartwright raised a declaration of interest as an organisation she had co-founded (Chase Lighthouse) utilised Pye Green Community Centre.

Both were confirmed as a declaration of interest and not a conflict of interest.

Cllr Kathryn Downs presented the confidential Paper on Pye Green Community Centre. The four options presented in the Council Paper were thoroughly discussed for around one hour. Cllr Laura Harrison stated that she would like there to be an amendment to one of the options, to offer current hirers the opportunity to tender for the running of the centre. Councillors stated that this request could have been seriously considered had the disclosure of confidential Council papers not occurred and that unfortunately the breach meant that staff and hirers were now experiencing misinformation and anxiety to the extent that a prolonged tender process could be irrecoverably damaging to all parties; this was regrettable given the public views heard.

Additionally, that Finance, Personnel and Operations (FPOps) Committee is tasked with reviewing the remit and budget implications of retaining the Operations & Regeneration Manager and Community Centre and Administration Officer, with a view to no overall reduction in hours/salary.

## Summary

Local residents have expressed concerns at the lack of litter bins along Pye Green Road – namely next to the bus stop and by the field adjacent to the new estate. This has resulted in residents in Pye Green litter picking weekly for years when it could be resolved by the installation of a litter bin. There is an ongoing issue of people discarding dog waste bags in the field and on the pathway which could be addressed by signage and litter bin.

Residents have also expressed concerns at the lack of snow grit bins across Hednesford, in the winter weather this results in areas being impassable by car and leading to slips and falls within the town centre.

Hednesford Town Council has contacted Cannock Chase District Council and Staffordshire County Council. They do not have the funds to resolve and purchase litter bins and snow grit bins this however they are able to assist if Hednesford Town Council funds the items required.

## Recommendation(s)

Hednesford Town Council holds CIL funding (Community Infrastructure Levy) that could fund improvements in Hednesford such as new litter bins and snow grit bins.

Is recommended that Hednesford Town Council reinvest the CIL funds (raised from developers) back into the local community to address their needs and allocate 10% of the current funds held (£8,000) with the purchase of 6 litter bins and 6 snow grit bins.

CIL is a levy that Councils can choose to charge on new developments in their area. The money should be used to support development by funding infrastructure that the council, local community and neighbourhoods want.

4.	Conclusion
	CIL funding is to be reinvested back into communities and this would be a valuable project that would directly benefit the area and residents.
5.	Recommendation(s)
5.1	Proposed that Hednesford Town Council approve the scheme and allocate 10% of the £85,000 CIL funds to this project and reinvest back into the community on items the public are requesting.
	This would be a trial project comprising of 6 litter bins and 6 snow grit bins and would be evaluated after completion to identify further areas that could benefit from such items.



Below Iv spoken about how our group help mentally and physically, then Iv also added messages from members on how it's helped them out too at the bottom of the letter Iv just spoke about myself and how it will effect me, my business, and my family.

I hope you don't mind, and hope all of this can be put forward towards the next council meeting at the beginning of February.

My names (NAME REDACTED), I currently run the martial arts academy (EHMAA) out of the centre, and have done for the past 17 years.

When parents reach out to learn more about kids martial arts, they often have a variety of questions and concerns. Many of them wonder if taking part in martial arts will make their child violent or cause them to get into fights. While other parents want to know if it will distract them from school or other responsibilities.

While the easy answer to both of these questions is a resounding "No," it's important to dive deeper into the benefits of martial arts for kids.

Believe it or not, it's not all about punching, kicking, and throwing each other on the ground. It is about finding a balance between mind, body, and spirit.

I have been at this club for 4 years and in that time I cannot put into words how much this class means to me. I have learnt so much, met so many new people and gained so many key skills I will take with me for the rest of my life. This club brings so many different people together from all over the Cannock Chase area.

This club has helped with my confidence, physical and mental well-being and I have made so many friends in the time that I have been a member.

Especially to take this away at a time of such economic uncertainty when we should be supporting small businesses not shutting them down & This club creates a strong feeling of community, positivity and support and to take that away from the people of this community, both young and old, would be of great detriment to the people of this area.

My son looks forward to his weekly lessons that have become a major part of our routine. EHMAA is a key part of our community and I am proud to say my son is a member.

I would like you to reconsider any plans to close down EHMAA and help it stay a part of our community.

This would be devastating news for my

boys who absolutely love attending there EHMAA kickboxing classes, maybe a Councillor from hendsford Town should pay a visit and see a class, to see what it means to everyone that attends and the hard work that is put in from staff week in week out. Self defence could save a life.

I don't think they understand how much the club means to everyone involved and how much it helps local kids: (its my second home and im sure its not just me who feels this way, by taking the community centre away from the community theyre doing more bad then good!!!

My daughter hasn't been training for long, just a few months but already loves going! EHMAA is more like a family and for kids that's the sort of environment they need. It's fantastic for kids that struggle socially, have confidence issues or just need a little bit extra. Emil and the team are absolutely fantastic with all the students and to take this away would be disgraceful!

At a time when young adults and children face increasing problems with mental health and a rise in obesity due to poor diets and sitting around on gaming consoles, they want to close down a club that tackles both these issues and more? (NAME REDACTED) could never seem to keep interest in various clubs until joining EHMAA, from the very start he was welcomed into a team environnement and encouraged to work hard and learn discipline and also fitness and wellbeing. This club and its central position to the area is invaluable and needs saving st all costs.

You gave us our first chance as a company, allowing us to come down and work with your club. Yours and your teams passion and dedication was clear to see and it was fantastic to see so many people of all ages enjoying each class whilst learning so many new skills. What you provide is an essential service for any person. The opportunity to learn, grow and develop in a dynamic environment with so many different people.

You have our support 100%

My son loves this group, he has gained in confidence, ability and the whole experience is enabling him to grow into a well rounded young person. The coaches give so much dedication and commitment to the local young people and I cannot praise them enough !

My girls have not been coming too long but it's clear to see they have fallen in love with the club! They can't wait to get there kit together and come train with everyone! They have gained so much confidence which they was previously lacking!

What can I say in absolute shock to hear this. Been going to this club for best part of 8 years now and (NAME REDACTED) are part of our family. I really think the people that are voting should come to one of the classes just to see how the kids and adults enjoy their time at the club. when we first started my two girls had no confidence at all, they will now walk into any room with there heads held high and that's all down to the coaches at EHMAA. It would be a crying shame if our club was taken away.

This is awful! My daughter suffers with anxiety and is 11 now and the support you have given her has helped her fight this, she is so much more confident now which has helped her transition to high school. As a single mother this academy gives you the opportunity to attend as a family. The academy embraces diversity as a key value and is extremely professional and teaches not only to an extremely high level but teaches us respect!! (NAME REDACTED) absolutely loves coming to EHMAA and has made lots of friends .The coaches are all amazing there and help to build confidence and resilience in all the children .Not to mention that during a pandemic they're helping with their mental health, physical wellbeing whilst keeping the children happy and off the streets .Helping them to learn valuable self defence skills and lets face it in a society with live in today where we all may need it.

We have a great club that is building something in this area. At the end of the day we are a club with huge potential and we will back you

This club and the coaches made my son (who has Autism) start believing in himself and have something to look forward to every week! It has been extremely hard to find a group in the area that is so kind, motivating and encouraging, if this stops, he will be devastated!!

I have only been training at EHMAA for a few months now but I have witnessed first hand the respect that is taught, especially to the younger students, which (NAME REDACTED) rightly mentioned is a rare thing these days. I remember my first training session, how welcoming and friendly everyone was. It will be a real shame and a massive loss to so many if we can no longer train. As I said, I have only been training a few months but the confidence and positivity that I have gained is amazing

EHMAA is a fantastic place for so many reasons, I've only been training for half a year but I already feel like part of a family. You can see every week the skills and life lessons people take away from the training, it's not just about the loss of somewhere local to train for people it's about loosing that community of people, where there are so few outlets for that in the local area.

A community centre is exactly what it says, a centre for the use of the community, to enjoy and take part in their chosen hobbies and pass times. It's never free, every club pays a fair financial contribution to the facility. That goes for me and my kids who have paid to attend EHMAA over the past 12+ months. My daughter only last week was awarded the junior student of the year award, to throw this away would be an absolute tragedy. Let's hope hope sense and community spirit prevails.

To close EHMAA would be a very big loss to the community. (NAME REDACTED) have put every effort for all ages to gain confidence, the academy is about getting fit, help with anxiety for some, and big confidence. To close is a big failure to a very good cause. Kickboxing is a confidence build for every age. Thank you (NAME REDACTED) for everything you have taught my family

My kids have been going here now for approx 5 years, not only have they learnt valuable self defence (that will help protect them from the mindless idiots that hang around the parks terrorising local kids), but they've also learnt so much about self discipline, focus, attitude and probably more important than anything they've made some great friendships! A community centre is here to serve the community, as should be a council and its members, not simply abuse the position to benefit themselves.

This is an absolute disgrace to close the community centre of which local businesses rely on! ? EHMAA has helped thousands of people stay fit and healthy of which we need more than ever. The dedication and hardwork that the coaches put into time spent training kids and adults is amazing, that cannot be taken away from them! My two boys have thoroughly enjoyed four years at EHMAA building on their physical and mental health including their discipline and confidence in their capabilities. Would be terrible for this to be taken away from them and many other people who have found something they thoroughly enjoy. Keep fighting

I started at the club in 2013 at the age of 44. Even though my age was against me I was welcomed as if I was a young teenager. I have come a long way since then. Not only am I learning a new skill, I have made new friends and now help as an assistant. Seeing, helping and supporting the youngsters develop their confidence and self worth to surpass there own goals is very rewarding to see. EHMAA is an organisation that like so many well run clubs should be supported by the local council and community.

During the 17 years at the centre, our group have supported members of the local community, from young children (age 3 being the youngest), through to fully grown adults (aged 70 our eldest ever member), from all walks of life. We've seen 1000's of the local community walk through the door. Some have been with us only a few months and others years, and we've positively impacted their lives along the way.

Through my time coaching we've coached members through their grading syllabus, and members through to regional, national & international champions. Without this centre and our as we class it as, none of this would of happened.

We thrive from a challenge and love to see members progress, not only within our academy but in the "real world" too.

We build champions not just on the mats but "champions for life", and this is what drives us. Making everyone that comes through those doors, a better version of themselves.

The effect of us losing the centre, is huge, as our academy has been established at the centre, and also those set evenings, and will impact our member base hugely, the community and what we offer. In fact losing this centre we will lose over half of our member base. Taking this away will not only impact me financially but it will also stop people doing what they enjoy, throughout the week, with like minded people.

The community centre, is meant to be used and for the whole community, not one individual group.

I hope this decision can be reversed and the groups that are in, keep continuing to serve the members of the local community in the positive ways that they do.
