Cllr Jagger raised a query with regards Section 106 agreement signed in September 2021 and the allocation of the sum of £7,500 (index linked) for "improvement works to provide additional cycle parking facilities at Hednesford Railway Station" and the sum of £7,000 (index linked) to be paid to SCC and used for "monitoring and review of the Travel Plan" and to "appoint a Travel Plan Co-ordinator".
