

Community Infrastructure Levy:

The CIL Regulations 2010 (as amended) state that the Local Council must spend the CIL income they received from the District on:

The provision, improvement, replacement, operation, or maintenance of infrastructure;

or

Anything else that is concerned with addressing the demands that development places on an area.

Please view attached Community Infrastructure Guidance for Parish and Town Councils

Prosperity Fund:

The Prosperity Fund can only be used for anything not already accounted for in the 2023/2024 budget and MUST achieve one or more of the following outputs and outcomes:

Outputs:

Number of neighbourhood improvements undertaken (this could be benches installed or given a new look, or bus shelters etc)

Amount of public realm created or improved (m2) (this could be planters installed / hanging baskets / benches / cleaned areas / mowed areas etc)

Number of local events or activities supported

Number of organisations receiving non-financial support (this one relates to town centre / high street businesses - for example content or town advertising that may support local businesses)

Outcomes:-

Number of neighbourhood improvements undertaken

Number of local events or activities supported



Amount of green or blue space created or improved (m2) (e.g. for blue space - water features

Increased footfall (The Council is in the process of purchasing footfall data to help monitor this)

Reduced vacancy rates (vacancy rates are monitored quarterly across Cannock / Hednesford / Rugeley town centres - it would be useful if Bridgtown / Chadsmoor / Norton / Heath Hayes could start to monitor this information for your High Streets too)

Increased users of facilities / amenities (increased bookings at community centres for example)

Improved perception of events (perhaps will have to survey attendees at events to see if their perception changes as the events progress across the years of the programme)

Guidance needs to be sought from CCDC for both funds prior to spend
